RENTAL AGREEMENT, RELEASE AND ACKNOWLEDGMENT OF RISKS

This agreement is between Uncle Mikey's EZ Bounce, LLC. ("UM-EZ Bounce") and _____ ("Customer") for the above referenced invoice.

Customer hereby grants UM-EZ Bounce the right to enter said property for the delivery and pick-up of the item(s) at approximately specified times.

I understand and acknowledge that the activity to be engaged in through my rental of an inflatable interactive amusement item brings with it both known and unanticipated risks to my guests, my invitees and myself. Those risks include but are not limited to falling, slipping, crashing and colliding and could result in injury, illness, disease, emotional distress, death and or property damage to myself, my guests or invitees.

I voluntarily release, indemnify, hold harmless and discharge UM-EZ Bounce and any and all associated companies, from any and all liability, claims, demands, actions or rights of actions whether personal to me or to a third party which are related to, arise out of or are in any way connected with my rental of the item(s) including those allegedly attributed to negligent acts or omissions. I agree to reimburse any reasonable attorney's fees and costs that may be incurred by UM-EZ Bounce in the defense of any such liability claim, demand, action or right of action.

In the event that I file a cause of action against UM-EZ Bounce, I agree to do so in the state of Georgia, and I further agree that the substantive law of the state shall apply in that action without regard to the conflict of law rules in that state.

I acknowledge that I have adequate homeowners insurance, renters insurance, and/or other liability insurance to cover any bodily injury or property damage which may occur to myself, my guests or invitees from the use of the item(s) or else agree to bear the costs of such injury or damage myself.

RULES: Customer agrees to follow all rules provided at all times during the operation and use of the item(s). If not attended by UM-EZ Bounce, Customer agrees to supervise both the item(s) and their use at all times.

WEATHER POLICY: UM-EZ Bounce reserves the right to cancel due to rain or high winds. Bouncers cannot be used if there are winds of 15 mph or more. If the sky is overcast or if there is a light rain with no wind, we can still set up our bounce houses. If we show up at your house and you elect to cancel the event, no payment is required. However, if you elect to proceed with the party, there is no refund once we have set the bounce house up. If a delivery charge applies, Customer agrees to pay delivery charge if not canceled prior to arrival of delivery truck.

TITLE: Customer shall keep the item(s) in his/her custody at all times and shall not sublease, rent, sell, remove from the delivery address, or otherwise transfer the item(s). The item(s) shall remain the property of UM-EZ Bounce.

DISCLAIMER OF WARRANTIES; LIMITATION OF LIABILITY: UM-EZ Bounce makes no warranties or representations, either expressed or implied, with respect to the items(s) under this agreement, all of which are hereby disclaimed and excluded by UM-EZ Bounce, including without limitation any warranty of merchantability or fitness for a particular purpose or use. In no event will UM-EZ Bounce be liable for any indirect, special, incidental, or consequential damages of any character arising out of or in connection with the use of the item(s), including, without limitation, any damages arising out of personal injuries while using the item(s).

FOOD MACHINE RENTAL: Food Machines are to be operated by an adult only. A copy of operating instructions for each food machine will be provided along with each machine.

DAMAGE: Customer agrees to return the item(s) in the same condition in which they were received. If items are damaged, lost and/or stolen, the customer agrees to pay for all repairs and or replacement.

☐ Absolutely no "Silly String", gum, candy, drinks, food, cigarettes, confetti, pets, or any other substances are allowed in the Inflatable Unit(s). Customer agrees to pay \$50 for the removal of Silly String or Gum.
Bounce Houses are NOT to be used wet.
